WHO SHOULD ATTEND?

This program has been purpose designed for internal or external consultants who wish to continue their professional development and be at the forefront of current consultancy practice.

ENTRY REQUIREMENTS?

A minimum of five years consultancy experience is expected.

HOW IS THE PROGRAM RUN?

The Diploma is a practical Vocational qualification, nationally accredited in Australia, which focuses on real workplace skills and knowledge, used by professional consultants in their everyday dealings with clients and stakeholders.

IS PROGRAM DELIVERY FLEXIBLE?

This highly flexible program provides candidates with learning opportunities that are tailored to their particular industry and work role. - 7. CONMRP507 Manage resources of a consultancy practice**
 - Manage self and stakeholders
 - Implement practice information requirements
- 8. CONMMP508 Manage planning and operations of a consultancy practice**
 - Review practice operations
 - Contribute to, monitor and review strategic plan
 - Support application of financial guidelines
 - Monitor financial activities
